Definitions

- Reshoring: Bringing work back to the U.S.
- Antonym: Offshoring
- Synonyms: Backshoring and Onshoring
- Nearshoring: Includes U.S., Canada & Mexico
- Outsourcing: Work done by another company, wherever located
- In-house: work done in the company's facilities, wherever located

Reshoring Initiative's Objectives

- **Change the Sourcing Mindset:**
 - From: “Offshored is Cheaper.”
 - To: “Local Reduces the Total Cost of Ownership.”
- **Train:**
 - OEMs: Why to source local.
 - Suppliers (and unions): How to “sell” local sourcing.
- **Do the best we can on the unlevel field now!**

The Industry-Led Initiative Provides

- Free Total Cost of Ownership (TCO) Software for OEMs and unions/suppliers
- Online Library of 98 reshoring articles
- Media coverage of the trend: WSJ, USATODAY, IW, CBS, CNBC, etc.
- Regional Initiatives

Logical Foundation

60% of manufacturers:

- Apply “rudimentary” total cost models
- Ignore 20% or more of the total cost of offshored products*

51% of companies found no financial benefit in offshoring**

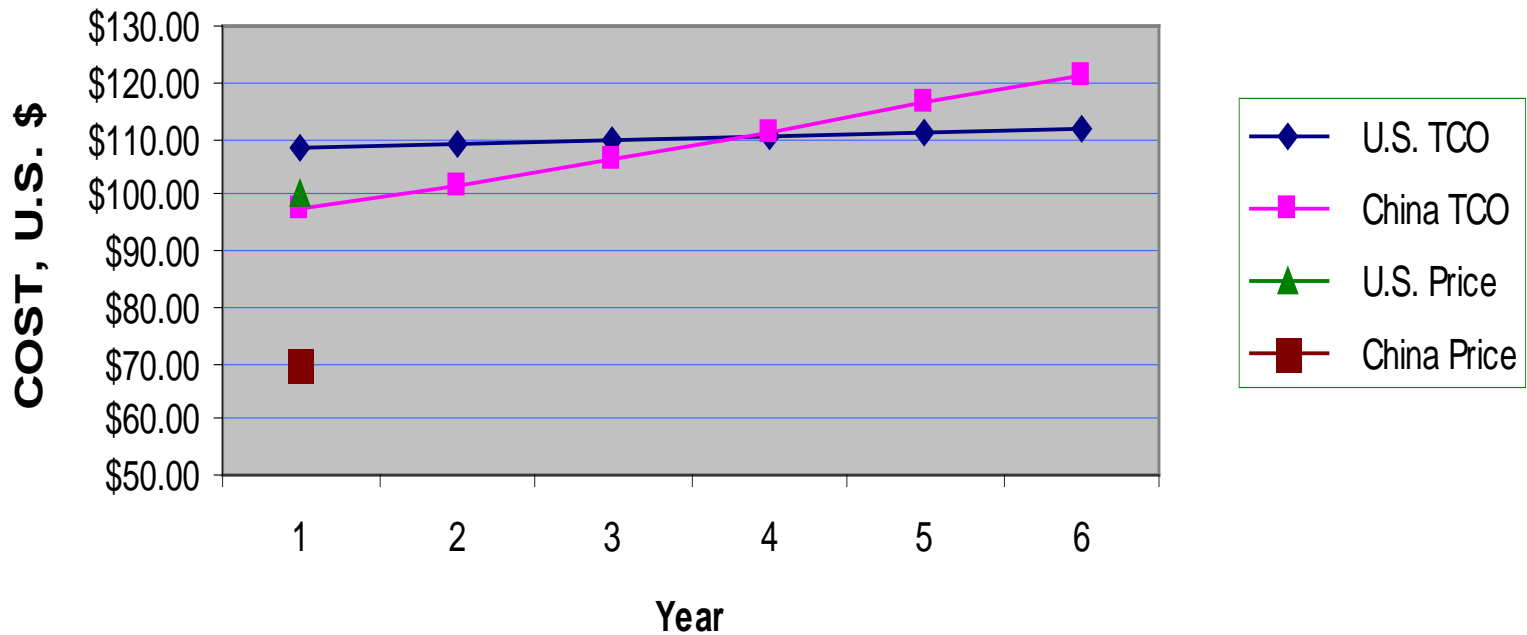
Chinese unit price	\$70

Quality*	2%

Product liability risk*	0.5%
IP risk*	1.9%
Innovation*	0.5%
Trips/yr	2
Prototype cost*	\$5,000
Country political instability risk*	0.4%
Wage inflation, annual*	8%
Currency appreciation, annual*	5%

“As China’s Wages Rise, Export Prices Could Follow”

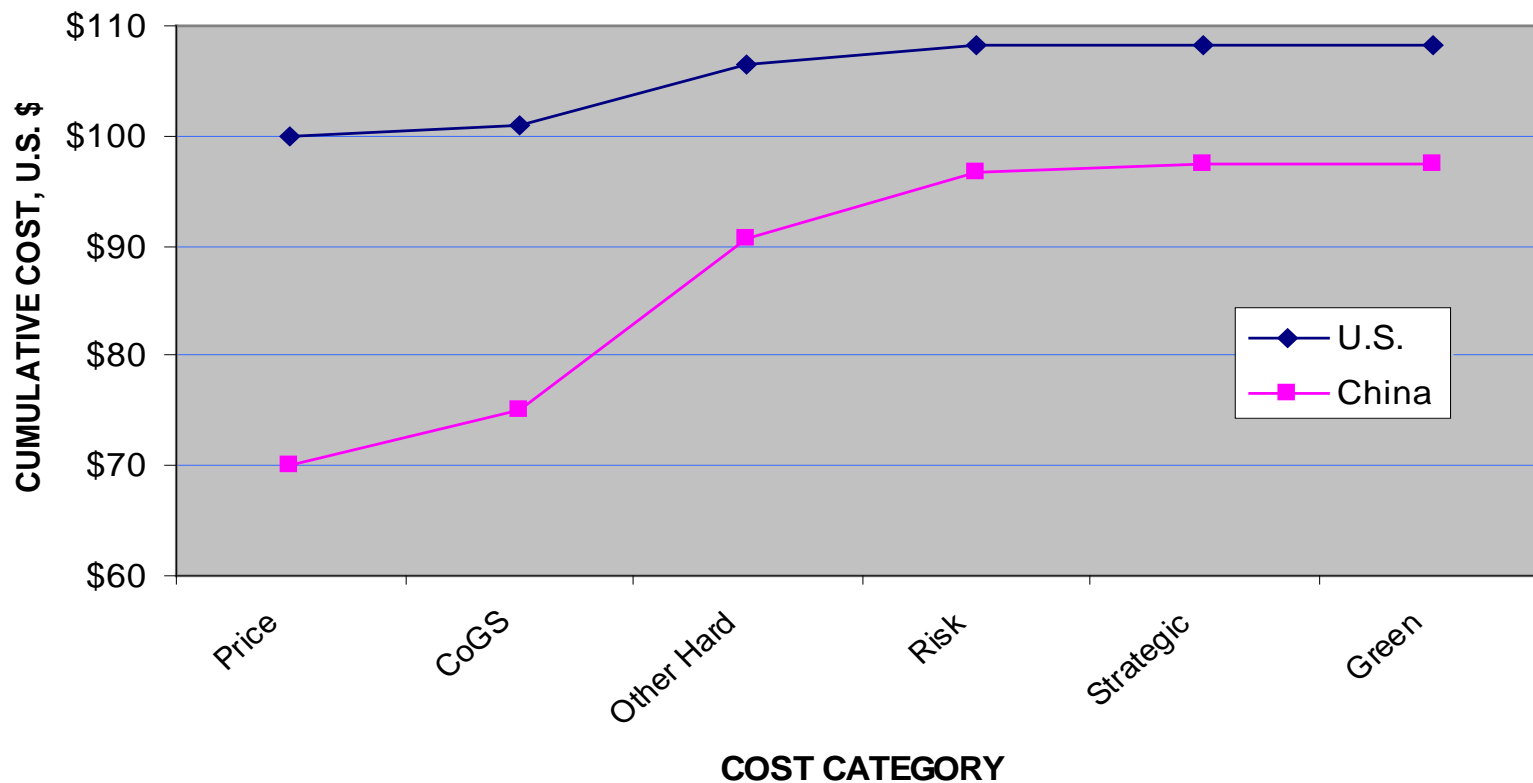
- 24% to 100% wage increases!

CUMULATIVE COST BY CATEGORY, YEAR 0: PARTS

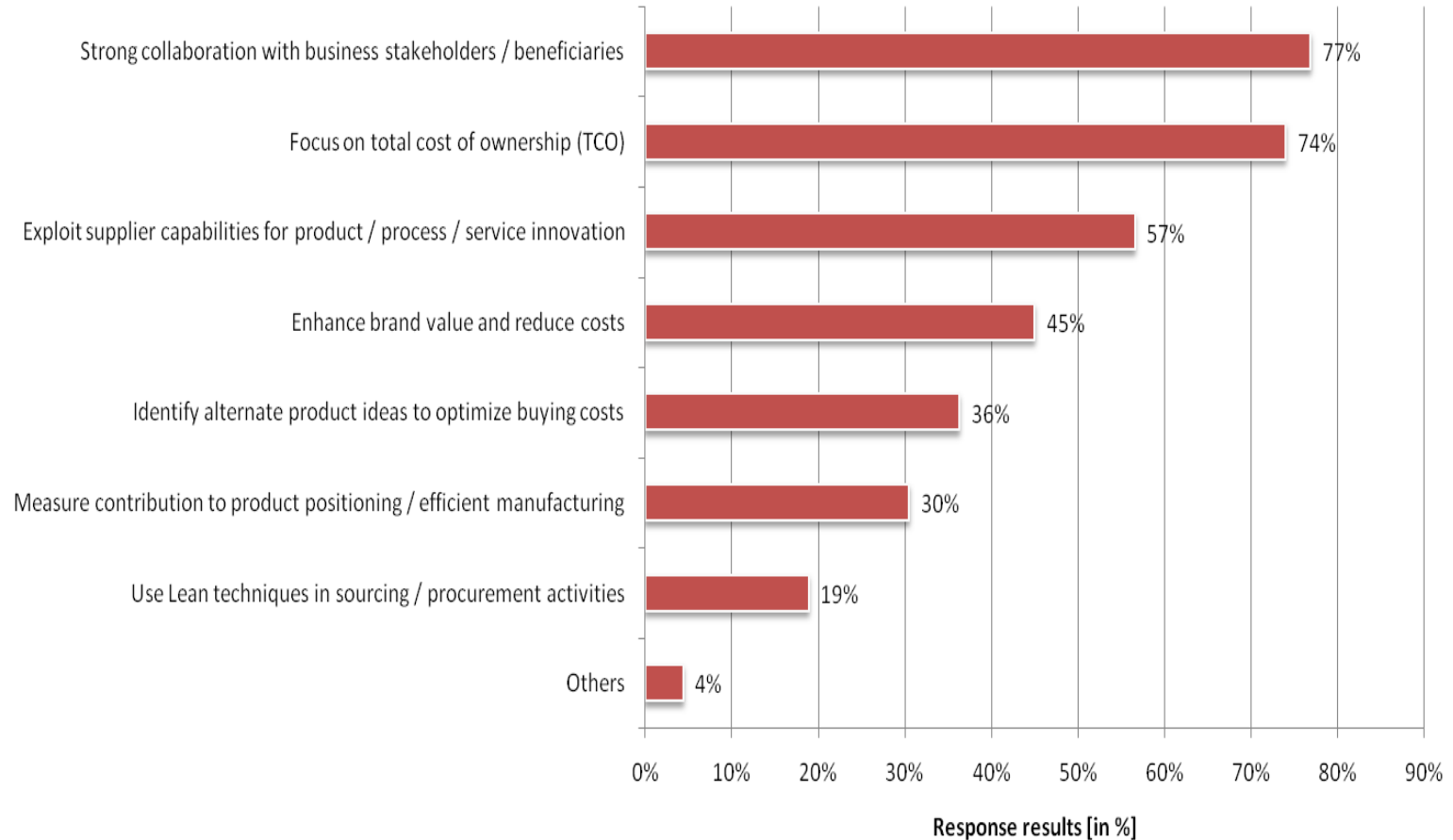


Using Estimator for the in-house case

Estimator written for comparing outsourced: offshore vs. U.S., so for in-house:

- Offshore: Use the transfer price from offshore instead of the “price.” Confirm that the transfer price produces the targeted ROI offshore.
- U.S.: Use the Company’s standard domestic cost: fully burdened, variable or ?

Top 10 Supply Chain Predictions 2011

5. “In the context of taking a broader view of **total cost, supply chain organizations will gain a new appreciation for shortening lead times through profitable proximity sourcing strategies.”**

Reasons:

- Improve overall service levels
- Retain key customers
- Focus on the “costs” of long lead times
- More balanced approach to global sourcing

Sourcing Moving Home Slowly

- 20% of companies brought sourcing closer in 2009
- Of which 59% reshored

- “End the practice of awarding business on the basis of price tag. Instead, minimize total cost.”

Offshoring contributes to Waste

<u>Toyota Wastes</u>	<u>Offshoring Contributes</u>
Overproduction	Large batch shipments
Waiting	Uncertain delivery/Inconsistent quality, port, customs
Transport	12,000 mi. inbound, 6,000 return (boat ½ full)
Overprocessing	More packing and unpacking
Inventory	In transit, cycle, safety stock, uncertain delivery and quality
Motion	Large batches require a warehouse. Travel, e.g. 2-3 weeks, 2-3X/yr
Defects	Much higher than local sources, extra inspection of materials and tolerances

Offshoring contributes to Instability

- Weather
- Port strikes
- Loss from mishandling
- Language problems
- Pirates

Impact on Product Strategy

- Impact of batch size and distance:
 - Offshoring → commoditization
 - Reshoring → differentiation/mass customization

Selling using TCO

- Focus on profit impact, risk management, strategic benefits, Lean, Green
- Overcome mandates
- Many Supply Chain Managers believe
- Work with natural allies
- Maximize the advantages of proximity
- Match “Chinese” price or TCO?
